NO COLD CALLING ZONE Our Sedgwick No Cold Calling Zone has been up and running since September and has hopefully deterred any Cold Callers. Thanks to Sheila Eccles, who gave us a grant from her Parish Allowance to cover the associated costs. We will be evaluating the scheme in the Spring at our Annual Parish Meeting and would welcome any feedback. In the meantime, please report any callers using the number on the back of this newsletter.

Village Hall Despite BT having problems providing a line to the Village Hall, we expect our new Broadband and free wi-fi service to be up and running by mid-December. It is wonderful to see that so many groups have used the Village Hall during 2016. A special mention goes to our thriving Rainbow, Brownie and Guide Groups who have achieved so much this year. David Willacy represented the Council recently by helping to judge their very own "Great British Bake Off".

Highways We have been informed that Cumbria Highways have assessed the road under the Canal Aqueduct in the centre of the village and that they will be carrying out work to increase pedestrian safety. Meanwhile, we continue to request repairs to the roads in the Parish; potholes by the River Kent and the broken road surface near Carex Farm have been mended. We are still waiting for repairs along Crosscrake Lane and have reported the poor condition of the pavements on Castle View and Hill Close. If you notice any problems, please let us know so we can register them on the system. We continue to be part of a group of parishes that operate extra road gritting to supplement the County Council's gritting routes and we also provide grit boxes at locations throughout the village- we do check them regularly but please notify us if you notice they need refilling.



Canal We have completed the first part of our work to restore the canal area. The canal bed has been invaded by self seeded ash and goat willow trees which are not only weak at the base and becoming unstable, but are creating a dense canopy of leaves which prevent light from reaching the lower levels. This is choking the herbaceous plants below and reducing the quality of the habitat along the canal and allowing the erosion of the towpath. After commissioning a Woodland Management Report, the work required to rectify the situation has been identified and is ongoing, partly funded by a grant from SLDC. This conservation work will ensure that the canal area continues to offer a variety of well maintained



habitats which will act as a corridor for wildlife. We have also extended the hand rail along the path to make access easier, especially with wetter weather on the way. The recent Towpath Trail consultation drop-in session at Sedgwick, run by the Lancaster Canal Regeneration Partnership was well attended. Their vision for the future of the canal was explained and although their planning is in the very earliest of stages, feedback from residents and users of the canal is invited via a questionnaire available on their website (see www.lancastercanalregenerationpartnership.wordpress.com.)



Millennium Field The new basketball hoop and football nets have already proved popular and a replacement swing has been fitted. Please make sure all young children are supervised and that safety notices are observed. Thanks go to George, David and Gerry for their continued work keeping the Millennium Field safe and tidy.



Affordable Housing Applications Helsington Community Land Trust has opened a register of interest for their new affordable housing at Brigsteer and we have been informed that Sedgwick residents are eligible for consideration. Consultations You will have received consultation documents regarding the National Grid's North West Coastal Connection proposals for the region. Although the Parish is not directly affected, we are planning to attend the local consultation meetings. Please visit the project website www.northwestcoastconnections.com for more details. We have also taken part in a recent Government Councillor Commission meeting led by Professor Colin Copus of De Monfort University, voicing the issues particularly relevant to small, rural, northern parishes. There are also consultations taking place regarding the Boundary Commission for England's proposals to change constituency boundaries in England.
