OUR ANNUAL PARISH REVIEW 2022-3

The past year has been marked by a return to the new post -Covid "normal". The Council have continued to work hard to represent residents and manage the amenities we are responsible for. **Our Council Meeting Attendance rates** are still high and we are delighted that ClIrs Doug Rathbone and Roger Bingham have continued to attend to represent Cumbria County Council and SLDC as they move towards the unification and the establishment of the new Westmorland and Furness Area. (W&F)

In the summer, we welcomed Val Macconnell to the Council and she is already working hard on behalf of the council and residents. Our wonderful Parish Clerk has delayed her retirement and agreed to serve the council until the summer.

The Millennium Field has been appreciated by all ages throughout the year and Gerry has worked incredibly hard to make sure the equipment and grounds stay in tip-top condition. Our long-term project to replace the tree slide, which is nearing the end of its lifespan is taking shape. We have sourced a replacement which will offer even better play opportunities and our mission to seek out grant funding has begun with an very supportive donation from Cllr Rathbone.

The **Canal Wildlife Area** continues to be provide a peaceful place to walk and enjoy nature. The wetland habitat has fared well during the periods of wet and dry weather. Our woodland management consultant continues to inspect the woodland regularly and James Park our Woodland Contractor has been invaluable responding to storm damage as well as carrying out necessary maintenance tasks. Ash Die Back continues to cause challenges but our policy of removal only when necessary has enabled in some recovery as trees show more resistance to the disease. The WI kindly donated 100 saplings which have been planted to replace the trees that had to be felled in previous years and they have become part of the Platinum Jubilee Queens Canopy. A commemoration plaque has been installed and will be dedicated as part of the Coronation celebrations.

The Lancaster Canal Regeneration Partnership is still planning to install a large iron sculpture on the aqueduct and an information board by the towpath. We still await action to repair the path over the aqueduct and improve safety on the steps. Their consultation with landowners, carried out in March 2021 has been released but stakeholders that took part have not been given access.


Highways issues take up a significant amount of our time. Repairs have been carried out and before the recent cold spells, were in good relatively good condition. However, several new deep potholes have appeared and following an audit of all Parish roads in January all faults are logged. Residents are asked to report faults using the online system because the more people that complain, the more likely they are to be assessed. Cllr Bingham funded the new Back Lane signs.

Our campaign for a 20mph speed limit in the village continues. The results of the speed data collected in November 2021 and January 2022 were not sufficient to warrant action but we have queried this judgement. The planned 20mph zones in Kendal will help the general call for more speed restrictions and it is a priority of the new W&F Council, so we live in hope.

Planning has become a significant area of concern. There are several very large-scale developments proposed for the south of Kendal and north of Natland and the Council have discussed the issues arising and made their objections known. We believe the disproportionate expansion of villages (eg the almost doubling of Natland) will undermine the character of the rural area and pose significant problems; the inevitable increase in traffic along the narrow minor roads in and around the Parish, caused by these developments, is an unacceptable escalation of the safety problems we already experience and the resulting increase in population will further stretch the local infrastructure, especially the sewage system. We have requested conditions be placed on any development that is permitted including making developers take responsibility for traffic safety measures in local villages, such as funding, monitoring and maintaining 20mph limits.

We were delighted to fund the Vaccination Clinic at the Village Hall in October. We continue to work to comply with all Data Protection Regulations, and financial requirements and maintain our popular website. We have attended a range of online training and consultation events and have represented residents at many external meetings. Finally, we have continued to oversee the Sedgwick No Cold Calling Zone to deter unwanted visitors and have updated the Community Emergency Plan which would help the community respond to a local crisis.

Financial Report 2020-21



There are only 189 properties in Sedgwick that contribute to our Parish income via the Parish Precept component of Council Tax and this number has fallen again this year; this makes maintaining our impressive range of amenities like the Millennium Field and Canal Wildlife Area a real challenge. We increased the precept by just 4% this year which only partly covered inflationary increases. The chart how shows we prioritised expenditure. We expect to finish the financial year with a small workina contingency and our reserve fund which safeguards the long-term future of the Millennium Field and Canal Wildlife Area

remains intact. We expect finances will remain extremely tight during 2023-4 because of inflation and smaller number of contributory properties and we have reluctantly increased the precept by 6% to help cover the costs. Draft accounts for the year will be available on the website prior to the Parish Meeting.

None of the Council's achievements would be possible without the contribution made by our brilliant team of Councillors, who give their time and expertise so generously and work so hard for the Parish and I would like to thank them on your behalf.

- From 4 May 2023, voters in England will need to show photo ID to vote at polling stations in local elections. This will include our local elections in May. From October 2023 it will also apply to UK General elections. If you don't have accepted photo ID, you can apply for a free voter ID document, which is known as a Voter Authority Certificate.
